TOWN OF VULCAN

By-Law No. 1085/88

A By-Law of the Town of Vulcan to provide for the maintenance, management, control and operation of the Vulcan Cemetery.

WHEREAS, it is deemed expedient to establish regulations for the control and operation of the Vulcan Cemetery.

NOW THEREFORE, the Council of the Town of Vulcan, duly assembled, enacts as follows:

THAT, in addition to the Cemeteries Act and Regulations thereto, the following rules and regulations shall apply:

1. Rights of burial in plots in the said Vulcan Cemetery shall be sold in accordance with the provisions set out in Schedule "A" to this By-Law.
2. The fees and charges for the opening and closing of graves shall be as set out in Schedule "B" to this By-Law.
3. "Perpetual Care" to be supplied by the Town of Vulcan means and includes seeding of plots and grave surfaces, and re-seeding when necessary, seasonal cutting of grass and weeds, and keeping plots in neat condition and appearance, and such other cemetery work as may be authorized by the Town Council.
4. A systematic selection of plots shall be made as designated by the Town Council or its authorized representative.
5. Grave openings shall be made towards the foot of the plot to provide for proper placement of headstones in line one with the other.
6. All costs of construction, erection and installation of monumental work or structures shall be the responsibility of the person requiring the work to be done.
7. All earth, debris, litter and rubbish arising or resulting from work done on any plot must be cleaned up and removed from the cemetery and the plot or plots left in a clean and tidy condition.
8. No plot or grave shall be raised above the level of surrounding ground.
9. No monumental work or structure of any kind, other than headstones, shall be placed on plots or graves located in that area of the cemetery designated as area "A" in Schedule "C" to this By-Law.
10. A headstone shall mean a stone inscribed with such lettering as may be desired by the owner of burial rites and being no more than 24 inches in height and set in a concrete foundation not less than 6 inches in depth and extending no more than 1 inch above ground level and extending a minimum of 8 inches beyond the base of the headstone.
11. The Town Council or its authorized representative shall have the right to remove fences, coping and other encumbrances and structures, including monuments, tablets or plaques heretofore or hereafter erected which by reason of neglect or age have in its opinion become objectionable. The Town Council shall first endeavour to contact the next-of-kin of the deceased and shall give 30 days notice in writing to such next-of-kin of its intention. Should the Town Council be

unable to ascertain the whereabouts of any next-of-kin of the deceased it shall post the notice of its intention in a conspicuous place in the cemetery for a period of 30 days and at the expiration of that time and provided that the objectionable condition is not corrected by any other person, it may order the work as authorized by this section.

12. Any notice required to be given under the provisions of Section 11 of this By-Law may be given by serving the owner personally with any such notice or by mailing such notice by registered mail at the Post Office in the Town of Vulcan, in a envelope addressed to the owner at his last know place of residence, and any such notice so sent by registered mail shall be deemed to have been received by the owner on the day following its mailing as aforesaid.
13. No person or persons shall be permitted to construct, erect, move or remove, for hire, any monument, gravestone, fence, or railing or other work for protection or ornament of a cemetery or grave plot without first obtaining a permit from the Town Office.
14. The placement of artificial flowers is prohibited between May 1 and November 1 of each year.
15. Schedule "D" shall determine the size of plots as to Adult, Baby and Cremation.
16. Cremation Plots shall be designated as Plots A - F, 17 - 28 and 45 - 56, Lot 1, Block 7. Only flat plaques 22" X 22" shall be allowed as a monument in the area designated as the "Cremation Only" section.
17. This By-Law shall have effect from the date of final passing thereof and shall rescind By-Law Nos. 599, 711, 781, 857, and 1019 and any other Town of Vulcan By-Laws pertaining to the operation regulation and control of the Vulcan Cemetery.

READ a second time this 25th day of July A.D., 1988.

READ a third time, by unanimous consent of the Councillors present and finally passed this 25th day of July A.D., 1988.
