

BYLAW NO. 1367-08

**A BYLAW OF THE TOWN OF VULCAN, IN THE PROVINCE OF ALBERTA,
FOR THE PURPOSE OF AMENDING BYLAW NO. 1085/88 "BYLAW TO
PROVIDE FOR THE MAINTENANCE, MANAGEMENT, CONTROL AND
OPERATION OF THE VULCAN CEMETERY.**

WHEREAS, the Council of the Town of Vulcan wishes to amend Bylaw No. 1085/88

WHEREAS, the Council of the Town of Vulcan has determined it is in the best interests of the Town to pass such a Bylaw.


NOW THEREFORE, the Council of the Town of Vulcan, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. THAT, this Bylaw shall be cited as the "Bylaw to amend Bylaw 1085/88".
2. THAT, Section 1 of Bylaw No 1085/88 be amended to read as follows:
Rights of burial in plots in the said Vulcan Cemetery shall be sold in accordance with the provisions set out in Schedule "A" to this Bylaw as amended by resolution of Council from time to time.
3. THAT, Section 2 of Bylaw No 1085/88 be amended to read as follows:
The fees and charges for the columbarium, opening and closing, disinterment of graves shall be as set out in Schedule "B" to this Bylaw as amended by resolution of Council from time to time.
4. THAT, Bylaw No. 1153/93, Bylaw No. 1191 and Bylaw No. 1261 or any other Bylaws of the same effect are hereby repealed.
5. THAT, this Bylaw comes into effect on January 1, 2009.


READ: A FIRST TIME THIS DECEMBER 8, 2008.
