By-Law No. 1106

A By-Law of the Town of Vulcan, in the Province of Alberta, to establish a schedule of fees for service charges provided by the Town of Vulcan and for the rent of Town of Vulcan equipment.

WHEREAS, it is deemed expedient to revise the schedule of fees as established by By-Law No. 1014 & 1057.

NOW THEREFORE, the Council of the Town of Vulcan, duly assembled, enacts as follows:

THAT, pursuant to the provisions of the Municipal Government Act, being chapter M-26, R.S.A. 1988 and amendments thereto, the following schedule of fees shall be charged for services provided by the Town of Vulcan and for the rent of Town of Vulcan equipment. All equipment rentals shall be subject to a rental agreement.
