BYLAW NO. 1302-A

A BYLAW OF THE TOWN OF VULCAN IN THE PROVINCE OF ALBERTA TO REVISE BYLAW 1302, BEING A BYLAW FOR THE PURPOSE OF CLOSING PORTIONS OF A PUBLIC ROAD (LANE) IN THE TOWN OF VULCAN

WHEREAS the Council of the Town of Vulcan may pass a bylaw for the purpose of closing any road as provided in the *Municipal Government Act*, R.S.A. 2000 Chapter M-26 (the "MGA"), as amended; and

WHEREAS on June 14, 2004, the Municipal Council of the Town of Vulcan, duly assembled, gave Third Reading to Bylaw 1302; and

WHEREAS on June 14, 2004, Bylaw 1302 was duly signed and passed;

WHEREAS the Land Titles Office for the South Alberta Land Registration District informed the Town of Vulcan that the written legal description provided to that office for the purposes of registering Bylaw 1302 and issuing certificates of title for the closed road (lane) was not complete and the legal description of the closed road (lane) needs to be revised; and

WHEREAS it is necessary to revise Bylaw 1302 in order to revise the legal description of the closed road (lane) used in Bylaw 1302;


NOW THEREFORE BE IT RESOLVED that Bylaw 1302 be revised by adding words to the legal description contained in that bylaw so the entire legal description for the subject road (lane) closure now reads as follows:

**A PORTION OF LANE IN BLOCK 4, PLAN 7000 AG
LANE, ALL THAT PORTION LYING TO THE SOUTH WEST OF
THE NORTH WESTERLY PRODUCTION OF THE NORTH
EASTERLY BOUNDARY OF LOT 11 IN SAID BLOCK,
CONTAINING 0.056 HECTARES (0.14 ACRES) MORE OR LESS.
EXCEPTING THEREOUT ALL MINES AND MINERALS.**
