

BYLAW NO. 1498-21

OF THE

TOWN OF VULCAN

IN THE PROVINCE OF ALBERTA

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF VULCAN IN THE PROVINCE OF ALBERTA FOR THE 2021 TAXATION YEAR.

Whereas, the Town of Vulcan, in Alberta has prepared and adopted detailed estimates of municipal revenues and expenditures as required, at the Council meeting held on May 10, 2020; and

Whereas, the estimated municipal expenditures and transfers set out in the budget for the Town of Vulcan, in Alberta for 2021 total \$6,183,293.00 and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$3,111,074.00 and the balance of \$3,072,219.00 is to be raised by general municipal taxation; and

Whereas, the requisitions are:

Alberta School Foundation Fund (ASFF)	\$586,099.00
Senior Foundation	\$ 70,584.00

and

Whereas, the Council of the Town of Vulcan is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

Whereas, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each sub-class of property, subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2000; and

Whereas, the assessed value of all property in the Town of Vulcan of Alberta as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Town of Vulcan of Alberta, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town of Vulcan of Alberta:


2. That this bylaw shall take effect on the date of the third and final reading.
