The Town of Vulcan MPC reviews and makes decisions on development and subdivision applications and advises Council on amendments to the Land Use Bylaw. The MPC is made up of four citizen representatives and two Council representatives.

- In addition to making decisions on development and subdivision applications, MPC's role also includes:
- Advising and assisting Council in achieving the orderly, economical and beneficial development of land;
- Maintaining and improving the quality of the physical environment of Vulcan;
- Making recommendations on designation of land;
- Providing input into special planning studies, planning policies and development related matters.

Time Commitment

- MPC meetings are scheduled to occur every month or as required;
- Meetings commence at 2:00 p.m. in Council Chambers;
- Preparation time for meetings;
- Four year terms with eligibility to reapply.

General Duties

- Understand and demonstrate a commitment to the commission's mandate and statutory functions;
- Prepare for meetings by reading agendas, minutes, reports and other documentation required to actively participate;
- Attend meetings regularly. Members-At-Large absent from three consecutive meetings or more in a one year period shall forfeit their office unless such absences are authorized by Resolution of the Committee and entered into the Minutes;
- Contribute skills and knowledge by participating actively in meetings and committee work;
- Make inquiries when clarification or more information is needed;
- Avoid any potential conflicts of interest;
- Understand and maintain confidentiality.
